## 9. PLANNING MATTERS

### 9.1 Pre-application Consultation - Fairways Nursing Home.

A formal response would be given when the planning application was to hand and all the supporting documents were available.

IOACC would be entering into consultation on how best to provide education for pupils aged 16 to 18 and also on the possibility of a new secondary school for Holyhead.
